1. I hereby represent that I am the legal owner of the pet(s) described above.
2. I hereby waive and release Ruthanna Ross and the caregivers of Home Fur Now from any and all liability which my pet may suffer, including specifically, but not without limitation, any injury or damage whatsoever arising from my pet's attendance and participation. I understand that the environment gives my pet the opportunity to play in close physical contact (including nose to nose) with other animals. As a result, no amount of supervision, sanitation, or personalized care can be 100% certain to prevent a pet from being injured or contracting and airborne virus or communicable disease. I understand that these risks are inherent to the services and hereby release Ruthanna Ross and the caregivers of Home Fur Now, from any and all losses, damages, costs and expense arising out of or in connection with any injury, communicable disease, damages related to such medical care or transport.
3. I hereby agree to be held solely responsible for any and all acts and behavior of my pet while in the care of Home Fur Now, including payment of costs for injury to staff or other animals or damage to facilities directly by my pet.
4. I hereby agree to indemnify and hold harmless, Ruthanna Ross and the caregivers of Home Fur Now, from any and all claims by any member of my family or any other person while attending the premises thereof, as a result of any action by any pet.
5. I hereby represent that my pet is of good health and has not been ill with any known contagious diseases within the past 30 days.
6. I recognize that the health of my pet is the owner's responsibility. I hereby represent that all required vaccinations are up to date. I will also continue to ensure that the required vaccinations will be kept up to date as long as my pet attends Home Fur Now. I will provide proof of vaccinations to Home Fur Now. I further understand that if my pet is found to have fleas and/or ticks, it will be bathed and/or treated by Home Fur Now at my expense.
7. I further understand and agree that in admitting my pet, Home Fur Now has relied on my representations that my pet is in good health and has not harmed or shown aggression or threatening behavior towards any other person or any other animal.
8. I further understand and agree that Ruthanna Ross and the caregivers of Home Fur Now, will not be held liable for any problems that might develop with my pet including, but not limited to sickness, disease, injury, running away and death, provided that reasonable care and precautions are followed.
9. I understand and agree that any problem(s) that develop with my pet will be treated, as deemed best by the caregivers at Home Fur Now, at their sole discretion and that I assume full financial responsibility for any and all expenses incurred.
10. I understand that if my pet is not picked up on time or by a date specified in a separate agreement, I hereby authorize Ruthanna Ross and the caregivers of Home Fur Now, to take whatever action is deemed necessary for the continuing care of my pet. I will pay Home Fur Now the cost of any such continuing care. I understand that if I do not pick up my pet, Home Fur Now will proceed according to the guidelines provided by the Ohio Revised Code 4741.30 for abandonment of animals by owner; procedure for handling. I also acknowledge that I will be fully responsible for all attorney fees and associated costs if I abandon my pet.
11. I agree that my pet may be videotaped, photographed and/or recorded. Ruthanna Ross, of Home Fur Now, shall be the exclusive owner to the results and all proceeds of such media.
12. I understand and agree that all fees must be paid at the time of pickup and must be in the form of cash, personal check or credit card.
13. I understand and agree that if I arrive 30 minutes or more from the scheduled time or outside of business hours there will be a \$10 inconvenience fee added to the bill.
14. By signing below, I agree and understand that I will be liable to pay for services through the date and time requested below even if I should cut my trip short for any reason. Further, if a pickup date is extended beyond the requested dates below, I agree to pay for the additional day(s) of service.
